ORDER**

WHEREAS, Rahmans College of Education, Jangaon Revenue Division, Hyderabad Road, Jangaon, Warangal District-506167, Telangana was granted recognition for offering **B.Ed** course vide order dated **12.01.2004** with condition that the institution shall shift to its own premises within three years from the date of recognition (in case the course is started in rented premises).

AND WHEREAS, the institution submitted shifting proposal on 20.09.2007 along with requisite fee of Rs. 40,000/- DD and some relevant documents.

AND WHEREAS, on 31.12.2014, letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

AND WHEREAS, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students on 20.01.2015.

AND WHEREAS, the SRC in its 276th meeting held on 7th-9th January, 2015 decided to issue provisional recognition orders to the existing institutions and the Committee also decided to maintain a check list of such cases for verification in October/November and for causing inspection.

AND WHEREAS, the SRC in its 284th meeting held on 9th-10th April, 2015 decided as under:-

- **On scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 12.01.2004.**

AND WHEREAS, a revised order was issued to the institution on 11.05.2015 for an intake of 100 students (2 units of 50 students each) with shifting condition. The institution submitted its written representation on 27.07.2015 along with documents.

AND WHEREAS, the institution submitted its written representation on 18.02.2016 along with relevant documents. The matter was placed before SRC in its 304th meeting held on 19th to 20th February 2016 and the Committee considered the matter and decided as follows;

- **Shifting fees difference to be paid.**
- **After receiving of shifting fees the application to be considered.**

AND WHEREAS, the institution submitted written representation on 23.02.2016 along with shifting fee and approved staff list.

AND WHEREAS, the SRC in its 305th meeting held on 25th - 27th February, 2016 considered the matter and decided to "**Cause inspection for shifting. Inform SCERT and University for admissions**".

AND WHEREAS, the inspection intimation was sent to the institution and VT members on 16.03.2016. The inspection of the institution was conducted on 20.03.2016. The VT report received in the office of SRC-NCTE on 28.03.2016.

AND WHEREAS, the SRC in its 302nd Meeting held on 09th-11th February, 2016 considered the letter from the Director School Education Department, Telangana State and it was decided that **"What with the 3rd March 16 time-limit pressure on us, it is not possible to go into these complaints at this time. Process and put up after March 16"**.

AND WHEREAS, the SRC in its 308th meeting held on 28th – 30th March, 2016 considered the VT report and decided as **"shifting permitted"**.

AND WHEREAS, order for shifting was issued to the institution for both B.Ed & D.El.Ed courses on 01.06.2016.

AND WHEREAS, as per the decision of SRC, the matter was placed before SRC in its 309th meeting held on 12th – 14th April, 2016 considered the matter regarding non fulfilling the deficiencies and decided to issue show cause notice for the following ground:


- **Shifting of college premises without the permission of SRC-NCTE.**

AND WHEREAS, as per the decision of SRC, show cause notice was issued on 13.05.2016. The institution submitted show cause notice reply along with relevant documents on 04.07.2016.

AND WHEREAS, the SRC in its 318th meeting held on 08th & 09th August, 2016 considered the matter and decided to issue Formal Recognition for B.Ed (1 unit) at the new site.

NOW THEREFORE, this order is issued granting recognition to the institution **Rahmans College of Education, H.No.3-13, Yeshwanthpura Village, Jangaon Mandal, Warangal District – 506175, Telangana** for conducting **B.Ed** course of **two years** duration with an intake of **50** students (one unit) from the academic session **2016-17** subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014, as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
2. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 4. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter –alia , the details of the institution, its location, name of the programme with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
 - a. Sanctioned programmes along with annual intake in the institution;
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:



- d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
5. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
 6. The institution shall make available the list of students admitted on its official website.
 7. The institution shall fill the information on GIS Portal on the NCTE website.
 8. The institution shall follow uniform Accounting System as brought out by ICAI and accepted by MHRD.

if the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this order be published in the official Gazette.
